The following two current Board members were appointed mid-term to fill vacancies and need to be confirmed:

Andrea Jakeman-Brown

Prior to her early retirement in 2015, Andrea was Centre Director with Scotia Private Client Group with Scotiabank, responsible for managing a team of ten wealth advisors and previously Branch Manager of Scotiabank's Victoria main branch for seven years. Because of her strong belief in the mission and values of Our Place, Andrea was the first Chair of our Advisory Cabinet, a team of business and community leaders who assisted Our Place's development team, since its inception in 2013. The following two Board members are seeking re-election, having reached the end of their current two-year terms:

Scott Daly

Scott is currently Secretary of the Our Place Board and is seeking reelection for a third two-year term. A long-time volunteer with a number of community organizations in both Victoria and his native Ottawa, Scott has been on the OPS Board since 2012 and has served as Secretary since March 2013. The following have been nominated for election to these five positions on the Our Place Board of Directors:

Karen Adams

Since changing careers a few years ago, Karen took additional training and began working in special education. Through these experiences, she has become increasingly interested in social justice issues and opportunities to help people living in vulnerable situations. Karen has an extensive thirty plus year career in accounting and financial services. Since moving to Victoria in 2004, she has worked in accounting, banking and now works as an educational assistant helping students with learning disabilities and special needs. Her volunteerism includes working currently as a facilitator and mentor for Restorative Justice Victoria and previously as Treasurer for the Victoria Highland Games Association and for Bays United FC (youth) for four years before becoming its President in 2008-09.

Bill Cantelon

Bill believes "it would be a privilege to share in the governance of a centre that embodies a socially-engaged spirituality where hope, compassion, acceptance and vision abide in harmony".
